

Dreamland Standard Poodles

1. The breeder guarantees the puppy has had its first round of immunizations, and has been dewormed every 2 weeks. That tails have been docked, and has had a thorough exam done by a licensed Vet between 6-7 weeks old. Buyer has 5 business days to take the puppy to a veterinarian for a new puppy exam. If the puppy is found to be in poor health, the buyer has the option of returning the puppy to the seller, at buyer's cost, for a full refund. The buyer will provide a written statement from a licensed veterinarian clearly stating defect or illness. If the puppy is not taken to a licensed veterinarian within the five business days, the health warranty is void.

2. The seller provides a warranty for 1 year after the date of sale against any debilitating congenital defects. In the event the puppy exhibits symptoms of a suspected debilitating congenital defect, the buyer must supply all requested veterinary records to the seller within seven days of informing the seller of the defect. (i.e . Proper testing such as OFA prelim hip testing or a PennHIP test must be submitted to seller if a suspected hip problem shall occur. Or cardiologist performed echocardiogram if heart problems are suspected) The seller has the right to request a second opinion from a veterinarian of the seller's choice at the seller's expense. If the puppy is euthanized or in any way disposed of, without a second opinion from the seller's veterinarian, the buyer waives all rights to a replacement puppy.

3. This warranty does not include any viral illness or infections, Hypoglycemia, improper bites, hernias, worms, Giardia or Coccidia. It also does not include any illness due to the ingestion of foreign objects, food, chemicals or physical injury.

4. If it is determined the puppy DOES have a genetic disorder that is identified within one year of purchase, the buyer has the option of a replacement puppy from a litter equal to or less than the price of the puppy bought OR buyer can pay the difference in cost for higher priced puppy. Your puppy need not be returned to us provided there is documented support of the medical condition. Shipping fees will not be refunded, and if it becomes necessary to ship a replacement puppy, those fees are to be paid by the buyer.

5. If the puppy should die from a suspected congenital defect within the 12 months of its date of purchase, an autopsy must be performed at the buyer's expense by a licensed veterinarian acceptable to the seller's own veterinarian. If the autopsy shows a congenital defect as the reason of the death, the seller will provide another puppy of equal value to the buyer. A written statement from the Veterinarian must be provided. This warranty is void in the event of an undetermined or inconclusive diagnosis.

BUYERS RESPONSIBILITY:

1. The buyer agrees to pay the seller a total sum of \$

2. The buyer bears all costs relating to the sale of the above animal, including transportation, extra vetting, and boarding after "go home date". The risk of loss or injury to the dog is the responsibility of the buyer at all times after the dog leaves

the seller.

3. The buyer agrees that their Standard Poodle will be housed indoors.
4. The buyer agrees to have their Standard Poodle groomed regularly (we recommend every 4-6 weeks MINIMUM) and to provide nail trims, brushing, ear cleaning and teeth brushing as needed.
5. The seller highly recommends feeding their Standard Poodle only a premium quality food. (We recommend Purina Proplan).
6. The buyer agrees to keep their Standard Poodle at a healthy weight.
7. The buyer agrees to make and keep annual veterinary appointments for their Standard Poodle, keep all immunizations current according to the guidelines of the American Veterinary Medical Association and properly administer heart-worm preventative medication.

IF BREEDING: -SHOW DOGS MUST BE CHAMPIONED THRU AKC or UKC before breeding-

ALL Dogs must be at least 2 years of age AND Buyer agrees to have their Dog Fully health tested to CHIC specifications -Including: DNA, OFA Hips/elbows or PennHIP, Eye exam and Cardiac exam and registered in OFA public database.

8. The seller highly recommends providing basic obedience training with their Standard Poodle puppy within the first year of owning their dog. To encourage our families to enroll in classes and pursue performance sports/conformation with their dogs, the seller offers a \$25 "bonus" to be paid to the buyer for each AKC obedience, sport or conformation title earned for the first year of ownership providing proof of title.

9. The buyer agrees to contact the seller immediately if the buyer determines they are unable to keep their Standard Poodle for any reason. The buyer and the seller will determine if the dog will be re homed/ returned to seller. Buyer also agrees they are not acting on behalf of someone else -as the dog is not to be resold to another party. (Not including Fully trained SERVICE Dogs)

10. The buyer agrees to never place the DREAMLAND Standard Poodle in a shelter, pound, research laboratory, or similar facilities.

11. The buyer agrees to use "Dreamland/s" at the beginning or end of titled name, if applicable. (If you have full rights, Dreamland needs to be used in official titling).

****Dreamland Standard Poodles has a NO DOODLE/MERLE breeding policy. Penalty will result in a \$4000 per puppy welped fine, along with any and all associated court costs/travel costs.****
